### General Authorization / Hold Harmless Agreement

Copies of all documents must be on file for all work to begin, as the 6-9 month completion cannot be started without these documents.

I hereby authorize Totally Awesome Taxidermy to perform taxidermy services on animals received under my account.

I understand that a 50% deposit, all documentation and pose instructions are required to begin work to meet the 6 to 9 month lead time; balance is due upon completion.

All work not picked up within thirty (30) days from final billing notification will be assessed storage fees of \$50 per game head and \$100 per life-size per month. Work not claimed within ninety (90) days from completion becomes the property of Totally Awesome Taxidermy.

In order to expedite handling of all trophies, all capes and life-size skins received will be automatically sent to the tannery for processing, unless notified prior to receiving the trophies into Totally Awesome Taxidermy.

Prior notification is required to avoid storage fees and a predetermined amount will be assessed. All clients with trophies stored after the 30 day notice will release Totally Awesome Taxidermy from any liability of possible damage to trophies, habitat and/or woodwork. All storage fees must be paid prior to the trophies leaving our facility.

I declare that all animals were taken lawfully and during the proper season with the required licenses, tags and/or permits. Totally Awesome Taxidermy must have this signed agreement, copies of proper legal documentation, license, tag and/or permit information on file before beginning any taxidermy work. Please send copies of all documentation immediately, as the 6-9 month completion cannot be accomplished without these documents.

I assume full responsibility for the legality of my animals, and indemnify and hold harmless Totally Awesome Taxidermy, its owner and employees from all claims, losses and damages (including attorney's fees and losses) should any illegality be discovered and the animal(s) seized by law enforcement officials. I further agree that if any of the items received for me were taken illegally or illegally offered for sale, I will be responsible for all penalties, legal fees, lost time and lost merchandise incurred by Totally Awesome Taxidermy.

In addition, Totally Awesome Taxidermy is not responsible for the damage or loss of trophies as a result of fire, flood, power outage, natural disaster, etc. beyond the control of Totally Awesome Taxidermy. All tanning is done at owner's risk and any tanned skin that is left unmounted for over a year is at risk of deterioration.
